

August 15, 2020 Meeting Minutes

Call Meeting to Order:

Chairman Emery called the meeting to order at 6:30

Agenda Items

1. Discuss meeting platform:

Commissioner Emery said he finds GotoMeeting easy to use. Commissioner Manning uses all of the platforms and has no issue with GotoMeeting, but said Zoom is the premiere platform. Commissioner Cullen said he feels Zoom is much easier to use and it does not have audio issues. Chairman Emery said he has not had any issues and would like to stay with GotoMeeting. Commissioner Manning suggested IT look into the audio issue. It was agreed to stay with the current platform. Commissioner Manning motioned to preauthorize \$15.00/mo. to purchase a transcript feature. Commissioner Cullen seconded. A role call was taken. . **All in favor at 6:40.**

2. Discuss abatement application 36 Harrison Ave:

Superintendent Gray said another data logger will be done tomorrow. He believes there is a continuous leak. He will speak to the customer to determine if they are using an irrigation system, and if it is on a timer. The item will be tabled to the next meeting.

3. Discuss abatement application 252 Dodge Rd.:

Having read the data logger, Commissioner Cullen said the meter is working and more information is needed. The item will be tabled to the next meeting.

4. Discuss discounts for veterans:

Superintendent Gray asked if the Board would be interested in giving discounts to Veterans. Chairman Emery said he believes the ability to verify status and maintain records would not be possible given the administrative time it would require. The Board agreed not to move forward with this idea.

5. Superintendents' report on current and future operations of the department: Superintendent Gray explained the drought has been upgraded to a level II status. He said the new water ban information will be put on the website, a press release will be issued, and a reverse 911 phone announcement will be released.
